DON'T OPEN THE DOOR

if an immigration agent is knocking on the door. We suggest asking ICE agents to slide the warrant under the door or through a window.

2

REMAIN SILENT

Do not answer any questions from an immigration agent if he tries to talk to you. You have the right NOT to answer questions about your legal status.

3

DON'T SIGN ANYTHING

without first talking to a lawyer. You have the right to refuse to sign any document before speaking with an attorney.

4

RECORD & REPORT

Take a photo and/or video if it is safe and it is a public space. Do not interfere with the interaction. Be as detailed as possible when sharing the interaction (Who, What, Where, When). It is recommended that the person recording have legal status.

WHAT RIGHTS DO I HAVE UNDER THE CONSTITUTION?



4th Amendment

- Right against illegal searches of your person or property
- ICE and police agents cannot enter your home or review your documents
- without your permission
- They almost never have a search warrant, DO NOT give them permission!



5th Amendment

- Right to remain silent and due process
- Includes refusing to sign documents
- Includes refusal to deliver documents



6th Amendment

- Right to a lawyer for criminal (criminal) cases, but not in matters of immigration
- Right to be notified how a criminal case affects your case or immigration situation

provide as much information as possible!
